Helping the Needy Locally

Our Missions Outreach Board is partnering again with the Town of Somers Social Services Department to provide Christmas gifts for children from families who are struggling financially. Because of the coronavirus, the Social Services Department is handling the gift giving differently this year. The department is creating a "toy shop" from which parents will select gifts for their child or children. The Director of Social Services has asked our church to provide gifts in the following categories:

From the Pastor

Dear Friends in Christ,

I hope you enjoyed a happy Thanksgiving and were able to count many blessings. This year has been a challenge for many of us to be sure, but God is good all the time and gives us grace that is sufficient to every need. This Biblical truth is one of the gracious promises of God (see, for example, 2nd Corinthians 12:9.) I pray that



you have been filled with all Christ-like graces to live an abundant life in all circumstances.

With the start of Advent on November 29 we are beginning a new church year. In addition to the four, ½-hour Wednesday evening Advent services on 12/2, 12/9, 12/16, and 12/23, we will try a "Blue Christmas"

Service" for the first time on December 19th. A Blue Christmas Service is also often called "A Service for the Longest Night" and is scheduled around the winter solstice when daylight is shortest. The Blue Christmas/Service for the Longest Night is intended to minister with compassion to those for whom Christmas, and the "holidays" in general, are an especially difficult time. There is, at this time of year, the constant refrain of family, gatherings, celebration, giving, abundance, and happiness. For those of us who do not feel like we have those things in our lives, the run-up to Christmas can be a long, lonely, and difficult season.

I invite all those who are feeling blue this Christmas to join us in our Service of the

Longest Night on December 19th at 7 PM. I also invite all those who care about and are in relationship with those feeling blue to join us, as well. Come out and join with us in sharing and acknowledging that God's presence is for those who mourn, struggle, or in any way walk in darkness — and that God's Word comes to shine light into our darkness. Everyone, regardless of church background (or lack of it) is welcome.

Wednesday Bible Study

After a Wednesday off during the week of Thanksgiving, our adult Bible study resumes on December 2nd at 9:30 AM. Studies will <u>not</u> meet on December 23, 24, 30 and 31.



CE Program (submitted by Lani Bortfeld & Pastor Graham)

The church school finished up our unit on Moses and the Exodus, from the book of Exodus, on November 22; there will be no church school on November 29. This unit proved good topics for discussion, as we discussed when is it OK to disobey the law of one's country (when it's against God's law, such as Pharaoh ordering the Hebrew midwives to drown newborn boys), how the Egyptians' fear of the growing Hebrew minority in their nation led to more & more repression, and how God cared for and met the needs of God's people in the wilderness, just as God cares for us and meets our needs in the wilderness of this pandemic. We had an average of four children in church school each week from both elementary and middle school; the teachers combined the elementary and middle school curricula to provide the best mix of activities for our children and youth. Classes were taught by Marj Butler and Lani Bortfeld, who enjoyed and sometimes were challenged by the children's questions.

We will start our Advent unit on Dec. 6 – "Jesus brings Good News", which will be on Zoom at 11:15am unless temperatures are above 50 degrees, in which case we'll have in-person church Saturday night or Sunday morning to see which format we'll be using.

This unit builds on the themes of the fall, where hoped-for children like Isaac, and children and youth who were saved from death, like Joseph and Moses, grew up to bring God's redemption to God's people. In December we will focus on how God's redeeming power came through two babies whose birth was announced by angels – John and Jesus. The children and youth are enjoying reading all of these Bible stories from the new Shine Bible story book, *All of Us*, which has excerpts and summaries of the Bible

story from the CEB Bible, followed by a shorter, easier version with graphic-novel-style illustrations. Each family who registers their children for church school this year will receive a free copy of this updated Bible resource; contact the church office or Lani Bortfeld at arcosirisquartet@msn.com for more information.

Below is the sequence of stories for December. In addition to the *All of Us* book, we are using the maps, family trees, crafts, activities, music, magazines, Bible posters and other supplements to reach children with a variety of learning styles. This month's Bible memory poster comes from

Luke 1:78-79; CEV:



God's love and kindness will shine upon us like the sun that rises in the sky. On us who live in the dark shadow of death this light will shine to guide us into a life of peace.

As we move to Zoom in the winter, it's important to have a variety of faces/voices in the session. You do not have to host the session, just present the lesson; Lani or

Graham will take care of the Zoom details. Currently, Marj and Lani are the only teachers, so we really would appreciate any kind of help. Just let us know when you can help reading the Bible story or lead a craft. You can sign onto Zoom from your home and read or lead the activity from there - we'll be glad to do a practice session with you!

The board continues to check in with families by phone after each CE meeting to update you on upcoming events and catch up with your family's joys and concerns. Each family has a CE contact person; please let us know suggestions, questions, concerns or prayer requests. Your Board of CE wants to hear from and pray for you in these challenging times. In this way, we hope that we can stay connected in Christ and encourage each other to keep the faith.



Heifer News

Grateful for the members of friends of our church, the Missions Outreach Board has given the gift of a pig and the gift of clean water to Heifer International in honor of the congregation. The Board chose a pig



because swine need little land and can thrive on crop and garden scraps. A sow can produce as many as 16 piglets a year. Since Heifer requires that the gift be passed on from family to family, many people will be blessed by the offspring of the Somersville pig. The gift of clean water, often achieved through the

installation of a well and treadle pump, can protect the health of whole communities that are presently forced to drink from a contaminated surface source of water.

Food Share

Members of our church help distribute food every other Wednesday from 1-1:30 in the parking lot of the Somers Congregational Church. If you are willing to assist, speak with Marge Morgan. Dates this month are Dec. 9^{th} and 23^{rd} .

Church Without Walls

CWW is an ecumenical ministry with the homeless held each Sunday at Court Square in Springfield. This outdoor service (held in any weather) begins at noon and concludes about 30-40



minutes later with a free lunch to any who would like to partake. Our Board of Missions, with your support, provides lunch (sandwich, snack, and fruit) on the 4th Sunday of each month when Pastor Graham leads the service.

Clothing Shed on the Green

We have had communication from St. Pauly's Textile (who provide the shed in the parking lot for the green) who tell us that assuming things keep trending in the right direction, they will reopen sheds as it becomes possible in each region over the next couple of months. There is no specific date for reopening it at this point and they ask for our continued patience. **Kiva** (submitted by Linda Longueuil)

During October, we were able to make 2 loans. The first loan went to Numeriano from the Philippines. He will use his loan to purchase farm inputs and insecticide for his rice crop. The second loan went to Joselyn, also from the Philippines. She sells ornamental plants and will use her loan to purchase fertilizer and other gardening supplies. In November, we made one loan which went to Abdoul in Kenya. He will use his loan to purchase products for his grocery store in a refugee settlement. This brings our total loans to 172. Their stories can be found in the KIVA notebook.

One loan defaulted in October. Naphitale from Zambia had requested a loan to obtain a mill for his maize. Our loss was \$44.54. Two loans were paid off in November with currency losses on both which total \$2.32. Isako from the country of Georgia used his loan to finance his pursuit of a degree in Law. Anita from the Gs Dios Es Real Group in the Dominican Republic used her loan to purchase stock for her clothing business.

Ladies Aide Society

The next meeting of the Ladies Aide Society will be Tuesday, December 8. The time of the gathering depends on the condition of co-vid; if things seem okay, the group will gather for a pot luck holiday lunch at 12



noon in the social room of the church – otherwise, just a meeting will be held at 1 PM sans shared refreshments. All women will be notified as the date draws closer

The pre-Thanksgiving bake sale, held on November 21, was successful thanks to all who contributed to it – and supported it. Through the generosity of all who baked, canned, made candy and turkey pot pies, we filled tables (and a freezer) with goodies for sale. The sale ran for two hours on Saturday and more sales were made on Sunday resulting in income over \$1170.00.


About a dozen women took part in cookie decorating following a brief business meeting on November 10. We are grateful to Cathy Doner for leading us in this fun activity.

Florida church's free parking for beachgoers is now a federal religious freedom case November 13, 2020 Written by Hans Holznagel United Church of Christ News

If people park at your church to walk to a nearby beach, can you invite them to donate toward your youth group's mission trip?

A federal lawsuit seeks to answer that and other legal questions for Pass-A-Grille Beach Community Church, United Church of Christ, St. Pete Beach, Fla.



Situated one city block from a popular beach, the church has been letting the public park for free in its lot for years. Sometimes church teenagers are there to hand out informational fliers and invite donations.

In recent years, the City of St. Pete Beach has objected to those practices, saying they violate a zoning code. This summer the city ordered the church to stop letting beachgoers park there. On Nov. 4, a federal judge heard the church's request for an injunction to lift that ban for now; a ruling is pending.

But there's more to come in this case in

the Tampa Division of U.S. District Court for the Middle District of Florida. The church has requested a jury trial, saying inviting motorists onto its property and interacting with them are matters of religious freedom and part of its public mission.

Long history of welcoming the public

Pass-A-Grille Beach UCC has offered free parking for beachgoers and for various public events since 1957. Since 2016 it has collected voluntary donations. On selected days, young church members are on hand to welcome motorists, give out literature describing their mission trips and accept contributions in person, said Jeanne Haemmelmann, the church's associate minister for youth and young adults.

The church's senior-high group has about 50 participants, she said, and some need scholarships for the group's annual mission trips.

"Each youth who works the parking lot 'earns' \$15 an hour, which is actually a credit to their mission trip account," Haemmelmann said. "Each youth is responsible for raising most of the money for these trips, so this is one way that we ensure that every youth who wants to go on a trip is able to do so."

Besides funding scholarships, the donations are used to buy building supplies for work done on the trips. The next one – COVID-19 pandemic permitting – will be to an American Indian reservation in South Dakota.

"We only have youth out there during peak season and holiday weekends," she said. "We have raised anywhere between \$16,000 and \$24,000 a year."

Stationed at the parking lot entrance and wearing shirts identifying themselves as church members, the young people greet motorists in a low-pressure, friendly way, Haemmelmann said. "They say that the parking is donation-based and if you

would like to make a donation, it goes to support our mission trips. If people ask what the cost is, they are told there is no cost.

"Often people say they have no money and of course the same answer is given. No money needed. We are just happy to have people be able to use the lot."



Recent history of tension

The city first cited Pass-A-Grille Beach UCC with a zoning violation in the summer of 2016, alleging it was violating neighborhood rules by operating a commercial parking lot. A city magistrate heard the case and concluded that, while "paid parking" would be illegal, "soliciting donations and evangelizing to those who parked in the lot was not a violation," the church noted in this year's suit.

The city again brought the church before the magistrate in the fall of 2016 on the grounds that the youth had used a sign that said "fundraiser" and that this amounted to paid parking. The magistrate told them to stop using that sign but said free parking could continue and the church could still accept donations.

But objections from the city and some of the church's neighbors continued, leading to the current case. In July 2020, St. Pete Beach again told the church to cease, this time citing another code: "Off-street parking spaces shall be reserved for the exclusive use of residents, customers, patrons or employees of the principal use of the property they are designed and intended to serve."

Church's 'right to use its property'

The church responded in August with a federal court complaint, arguing that serving the public is part of its mission.

"Anyone that enters onto the church property is someone in need of God's love, and therefore akin to what a secular business would call a 'customer' or a 'patron,'" the church wrote. "The church is not a commercial business but rather offers the public the gift of a free place to park and the opportunity to support the church. Members of the public are free to donate, or not to donate, to the youth group when parking on the lot."

Among other legal points, the church cited its constitutional rights to free speech and expression and equal protection of the law. The latter is being violated, it said, because the city has not objected to beach parking at a shopping plaza or other nearby lots. The church also cited a federal law passed in 2000.


"St. Pete Beach is using an increasingly common tactic among cities and counties — cowering behind misinterpreted zoning codes — to limit or eliminate the religious freedom of its community members," said the church's attorney, Daniel P. Dalton, whose Michigan firm, Dalton & Tomich, specializes in religious-freedom cases. "The Religious Land Use and Institutionalized Persons Act of 2000 broadly protects Pass-A-Grille Church's right to use its property within the parameters of its spiritual mission, which is clearly the case here."

As part of its federal complaint, the church asked the court to issue an injunction that would allow it to continue its beach-parking program – and would stop St. Pete Beach from interfering. It also asked the court to declare the city's actions "arbitrary and capricious" and to rule that part of the city code "is void for vagueness and is unenforceable against the church."

After hearing arguments Nov. 4 on the church's requested injunction, federal Judge Thomas Barber ordered both parties to continue legal preparations and report back in two weeks. The jury trial requested by the church has not yet been scheduled.

Parking as hospitality

More is at stake than the use of parking spaces, according to the church.



"The city does not consider the many youth whose lives have been changed because of the donations that people freely give to support our mission endeavors," said Pass-A-Grille's senior minister, the Rev. Keith Haemmelmann. "The church is not the church if ministry and discipleship are defined by entering a church building, then leaving, because the church will be penalized if you visit a friend, walk the beach or break bread with a neighbor."

"The church is not a commercial operation, no matter what codes a municipality adopts. Our calling as followers of Christ is to build the Kingdom of God on earth, not a fiefdom on the beach. Without the ability to reach a workable solution with the City to continue using our parking lot as we have for many years, the only viable option was to ask the court to confirm our rights under federal law."

Welcoming people to the parking lot has spiritual dimensions, Jeanne Haemmelmann said. As the teens guide drivers to parking spaces, they "usually end up speaking with them about past or upcoming mission trips," she said.

"It is always so refreshing to hear people share their own stories of their experiences in youth groups growing up. Often people ask if we could offer a prayer for someone in their family and of course we are happy to do that. We also tell them about services at the church or let them know if they know of a youth who would like to join the group, they are welcome."
